Federal Coordination Regulations Section 5 Notification

On August 28, 2008, HMDC submitted to the Canada-Newfoundland and Labrador Offshore Petroleum Board (C-NLOPB) a project description for a proposed construction and operations program for up to six drill centres in the Jeanne d'Arc Basin area (the Project). The C-NLOPB determined that the Project would require an authorization pursuant to Section 138(1)(a) of the Canada-Newfoundland Atlantic Accord Implementation Act and Section 134(1)(a) of the Canada-Newfoundland and Labrador Atlantic Accord Implementation Newfoundland and Labrador Act.

The attached project description outlines the activities proposed for the Project, to be undertaken from 2009 through to the current estimated end of project 2036. The first phase of the project will be the Hibernia southern development, which includes the construction of a glory hole and the installation subsea equipment and flowlines. Each drill centre will be constructed for up to 11 wells, with tie-back to the Hibernia platform. Project activities are scheduled to commence in 2009.

A draft scoping document is attached for your review and comment. Comments should be forwarded to the undersigned on or before September 25, 2008.

The C-NLOPB has determined, in accordance with paragraph 3(1)(a) of the *Regulations Respecting the Coordination by Federal Authorities of Environmental Assessment Procedures and Requirements* (FCR), that an environmental assessment of the project under section 5 of the CEA Act is required. Pursuant to Section 12.2(2) of CEA Act, the C-NLOPB is assuming the role of the Federal Environmental Assessment Coordinator (FEAC) for this screening.

This letter seeks, pursuant to the FCR, to identify the departments or agencies that may have obligations as responsible authorities or as federal authorities and to set a timetable for conducting a screening.

Timing of Assessment

The C-NLOPB requests that the screening be carried out in a timely a manner as possible, and propose the following schedule:

If no response is received from you by the date indicated above, the C-NLOPB will assume that your department or agency has no responsibility to undertake an environmental assessment and is not in possession of specialist or expert information or knowledge.

Species at Risk - Section 79(1) Notification of Competent Minister

Pursuant to Section 79(1) of the *Species at Risk Act (SARA)*, the C-NLOPB hereby informs the Minister of Environment and the Minister of Fisheries and Oceans (the Competent Ministers) that the following Schedule 1 Species are likely to be in the project area under the jurisdiction of the C-NLOPB. A determination of the likelihood of adverse affects on these species will be undertaken during the screening process.

• Endangered: Turtle, Leatherback (*Dermochelys coriacea*)

Whale, Blue (Balaenoptera musculus)

• Threatened: Wolffish, Northern (*Anarhichas denticulatus*)

Wolffish, Spotted (Anarhichas minor)

• Special Concern: Gull, Ivory (*Pagophila eburnea*)

Wolffish, Atlantic (Anarhichas lupus)
