Thank you for the opportunity to review the EA Report for the Multiklient Invest AS Newfoundland and Labrador Offshore Seismic Program, 2017 to 2016. The CNSOPB has the following comments on the Report:

A portion of the project area includes Fisheries Management Area 4Vs. Some fisheries originating from Nova Scotia work in the 4Vs area.

It is not clear in sections 5.1.1 and A-11 of the EA Report if the proponent has consulted with or informed fisheries from Nova Scotia of the program plans.

It is recommended that the C-NLOPB seek clarification from the proponent. If fisheries originating from Nova Scotia are not yet aware of the program, it is recommended that the C-NLOPB request the proponent to make the commitment to inform these fisheries and/or fishing organizations, as the proposed program may impact them.

If assistance is required to determine which Nova Scotia based fishing organizations to contact, I am happy to provide recommendations.
