Hi Darren,

The Sustainable Fisheries and Oceans Policy Division would like to provide the following observations and comments from a fisheries perspective.

In relation to the Amendment of Environmental Assessment of Multiklient Invest Newfoundland Offshore Seismic Program, 2018–2023:

- While estimated impacts of eSeismic activity is low, the amendment provides information only on the additional eSeismic activity. There will be conventional seismic exploration occurring alongside eSeismic, therefore risks assessment of both activities compounded remains of concern. The impact of executing both activities in succession was not addressed in this document.
- There is only one test of eSeismic mentioned. Has there only been one test completed in a true oceanic environment? Testing in Brazil did not report on the SEL over a full sequence of eSeismic pulses and over a 24-hour period. Data gaps remain.
- Many of the benefits of eSeismic remain speculation, with the document stating "systematic well-controlled studies of animal responses to eSeismic sounds are necessary before the relative behavioral responses from eSeismic and conventional seismic sources can be meaningfully compared."
- Test location proposed overlaps with NAFO Division 3L; however, residual effects are predicted to be low to medium in magnitude for a duration of less than one month.
- Although there are low levels of interaction with the fishery expected, it is crucial that any activity or changes in activity be communicated effectivity with industry representatives and harvesters on the water. Failure to do so has been known to cause losses to gear and catch, therefore damaging the profitability of the fishery and the wellbeing of harvesters.
