ECCC-CWS has reviewed the CNOOC Petroleum North America ULC Flemish Pass Exploration Drilling Project 2021 EA Update and offers the following comment.

ECCC requests that the proponent add Leach's Storm-petrel to Section 3.1.2 (Marine and Migratory Birds) and Table 3.2 (Updated marine and migratory bird species at risk or other special conservation concern). Leach's Storm-petrel (Atlantic population) was assessed as "Threatened" by COSEWIC in November 2020 and is very likely to occur in the Project Area.
