On January 28, 2011, Statoil Canada Limited submitted to the Canada-Newfoundland and Labrador Offshore Petroleum Board (C-NLOPB) a project description for a proposed geophysical program in the Jeanne d'Arc Basin and Central Ridge/Flemish Pass Basin. The C-NLOPB determined that the Project would require an authorization pursuant to Section 138(1)(b) of the *Canada-Newfoundland Atlantic Accord Implementation Act* and Section 134(1)(b) of the *Canada-Newfoundland and Labrador Atlantic Accord Implementation Newfoundland and Labrador Act*.

The attached project description outlines the activities proposed for the geophysical program. An initial 3D seismic survey will commence in 2011 and subsequent 2D, 3D, electromagnetic, geohazard surveys, and possibly controlled-source electromagnetic (CSEM) surveys will be conducted over the remaining 8 years.

The C-NLOPB has determined, in accordance with paragraph 3(1)(a) of the *Regulations Respecting the Coordination by Federal Authorities of Environmental Assessment Procedures and Requirements* (FCR), that an environmental assessment of the project under section 5 of the *Canadian Environmental Assessment Act* (CEA Act) is required. Pursuant to Section 12.2(b) of CEA Act, the C-NLOPB is assuming the role of the Federal Environmental Assessment Coordinator (FEAC) for this screening.

This letter seeks, pursuant to the FCR, to identify the departments or agencies that may have obligations as responsible authorities or as federal authorities and to set a timetable for conducting a screening, and seek comments on the attached draft scoping document.

***Timing of Assessment***

The C-NLOPB requests that the screening be carried out in as timely a manner as possible, and propose the following schedule:

### Species at Risk - Section 79(1) Notification of Competent Minister

Pursuant to Section 79(1) of the *Species at Risk Act (SARA)*, the C-NLOPB hereby informs the Minister of Environment and the Minister of Fisheries and Oceans (the Competent Ministers) that the following Schedule 1 Species are likely to be in the project area under the jurisdiction of the C-NLOPB. A determination of the likelihood of adverse affects on these species will be undertaken during the screening process.

- Endangered: Whale, North Atlantic right whale (*Eubalaena glacialis*)  
Turtle, Leatherback (*Dermochelys coriacea*)  
Whale, Blue (*Balaenoptera musculus*)  
Gull, Ivory (*Pagophila eburnea*)
- Threatened: Wolffish, Northern (*Anarhichas denticulatus*)  
Wolffish, Spotted (*Anarhichas minor*)
- Special Concern: Wolffish, Atlantic (*Anarhichas lupus*)  
Whale, Fin (*Balenoptera physalus*)
