Hello Darren, Bill:

Having looked at the proposal and our past work associated with off-shore project, I feel our department should not be involved in this Environment Assessment. The antenna and its supporting structure would likely be attached to a building or another structure (like radio shack or crane) on the rig platform, and usually smaller than 25% of the building heights as noted in the section 20.(2)(a) of the Exclusion List Regulations, 2007:

20. (2) The proposed construction, installation, operation, expansion or modification of a radio communication antenna and its supporting structure within 30 m of a water body if

- (a) the antenna and its supporting structure are affixed to a building;
- (b) the project results in an antenna with a height no more than the greater of 5 m and a height equal to 25% of the height of the building to which it is affixed; and
- (c) the project does not involve the likely release of a polluting substance into a water body.

I would like to take this opportunity to request that future off-shore oil and gas production projects exclude Industry Canada from the environment assessment. This being maritime operation, radio communication would be similar to any other maritime vessel where antenna and their supporting structure are insignificant in relation to actual facility, be it a ship or an off-shore structure.
